HOUSE RULES

Austria Climbing Event GmbH

during the event

IFSC Climbing World Cup & Speed European Cup Innsbruck 2023



The following house rules apply on the entire event venue for the entire duration of the abovementioned event.

Scope of application

These terms and conditions of Austria Climbing Event GmbH apply to all business partners and visitors to the event venue in connection with the above-mentioned event. Visitors undertake to comply with them during their stay on the premises. Even those persons who do not purchase tickets themselves, or visit parts of the event for which no ticket is required, undertake to comply with the house rules by entering the event site.

By entering the venue (with or without ticket), the visitor submits to the instructions of the organizer and the house rules of the event premises: The regulations apply to every visit to an event. The visitor is obliged to inform himself about them, especially for safety reasons. By using the admission ticket at the latest, the visitor confirms knowledge of the house rules and their validity.

The house rules apply to: Sillside Area Outdoor (Climbing Center Innsbruck); Matthias-Schmid-Straße 12c, 6020 Innsbruck; during the above mentioned event.

Area of validity / Event time

These house rules apply to the above-mentioned event venue for the duration of the event: June 12 to 18, 2023. The event venue includes all buildings, rooms, facilities and open spaces used in the course of the event.

Access controls and stay

Visitors are required to undergo a ticket check (if applicable to the relevant part of the event), as well as a bag check by security before entering the event venue. It is also possible that an ID check will be carried out (especially for youth tickets to verify age). In the course of the bag check, the security service employed by the organizer, the supervisors and the security staff are entitled to search clothing, bags and containers carried by the participants for prohibited or dangerous objects at any time. In individual cases, such checks may also be carried out on visitors who are already on the event premises.

The security service, the supervisors, the security staff or the organizer are entitled to deny access to the event site to persons who may pose a security risk (e.g. due to excessive alcohol consumption or the carrying of prohibited or dangerous objects). The same applies to persons who refuse a search of their clothing, bags or containers or a possible ID check.

In the event of violations of the house rules, the organizer, the security service or the police are entitled to expel the offenders from the venue. After the end of the event, all visitors must leave the venue quickly. In addition, before parts of the events for which tickets are required, the premises will be completely cleared before admission, so the mentioned controls can be resumed.

Protection of minors

After 8 p.m., persons under 14 years of age are only allowed to enter the venue if accompanied by an adult. In addition, the Tyrolean Youth Protection Act, as amended, applies to the entire venue.

Prohibited items:

It is prohibited to bring any kind of objects and substances that may pose a threat to the interests of protection (in particular, a threat to the life and health of people, a threat to operational safety).

Prohibited are in particular:

- knives and weapons of any kind (any particularly dangerous object capable of threatening life or limb is considered a weapon)
- objects with weapon-like effect
- containers and bottles made of glass and other hard packaging that are breakable or splinter easily; cans, etc.
- flagpoles from 1.3 meters
- pyrotechnic articles
- animals, with the exception of assistance dogs
- bottle openers
- · iron bars and pieces of iron
- stones
- perfume bottles
- umbrellas with wooden or metal tips
- gas horns
- toxic, corrosive or staining substances or objects
- darts and similar throwing objects
- nail polish
- mechanically or electrically operated noise instruments (e.g. megaphone)
- laser pointers
- pepper sprays and tear sprays
- large or bulky objects such as ladders, stools, (folding) chairs, boxes, suitcases
- vehicles such as bicycles, skateboards, inline skates, scooters, segways, etc.
- strollers
- racist, xenophobic, national socialist, sexist or political propaganda material

In case of doubt, the classification of items as prohibited or permitted within the meaning of these house rules is the responsibility of the security service, the supervisors, the security staff or the organizer and the police. Persons carrying prohibited objects as defined by these house rules will be denied access to the event location. If persons are found in the event location with prohibited objects, the organizer, the security service, the supervisor or the security staff is entitled to expel the persons concerned from the event location.

Parking of vehicles

The parking of bicycles, electric scooters, segways or similar vehicles in the event location or the attachment of these to structures, fences, barriers, etc. represents a safety risk and is prohibited. There are designated places where such vehicles can be parked (especially in the southeast of the site), in all other places parking is prohibited. In case of violation, the vehicles can be removed and stored by the security service, the supervisors, the security staff or the organizer at the expense of the violating person.

Behavioral instructions during the event

Flashing lights of any kind are prohibited during the event for safety reasons. All persons entering the event premises must behave in such a way that other persons are neither harmed, endangered nor harassed. Furthermore, they must behave in such a way that no damage is caused to structures, facilities, equipment or objects.

Image recordings

Visitors take note of the fact that image recordings are occasionally made at events, which are subsequently used (television and radio broadcasts, photo, video, audio, etc.). The visitors give consent that the recordings made by them during or in connection with the event may be stored, evaluated and also used for commercial purposes by the organizer and/or other authorized persons (e.g. television broadcasters) without compensation, without temporal or spatial restriction, by means of any current or future technical process, provided that the use does not unduly infringe his personal interests.

The visitor acknowledges and agrees that for reasons of safety of all and for the punishment of violations of the law as well as violations of the house rules, video recordings of the spectator areas are made. Visitors are prohibited from transmitting, in whole or in part, audio and/or visual material, descriptions, results and/or statistics of the event via the Internet, radio, TV or other current and/or future media technologies, or from assisting others in carrying out such activities. Visitors are only authorized to take photographs, film, video or other sound/image recordings of events for private use. Any commercial use or use for commercial purposes of such recordings is prohibited.

Volume

Visitors are particularly reminded that the volume at events can be very high, posing a risk of hearing/health damage. In particular, children and persons sensitive to hearing are advised to take appropriate protective measures.

Liability

Attendance at events is at the participant's own risk. The organizer shall not be liable for any damages, unless it can be proven that the organizer acted with intent or gross negligence in violating its main contractual obligations. Any liability shall in any case be limited to the compensation of the foreseeable, contract-typical damage. Insofar as the liability of the organizer is excluded or limited, this shall also apply to the personal liability of its employees, representatives and vicarious agents. Accidents, damages and injuries are to be reported to the organizer immediately.

Behavior in case of danger

a) Dangers perceived by visitors:

In case of danger (accidents, fire, etc.), the security service, the supervisors, the security personnel or the organizer must be informed immediately. If necessary, the following organizations can also be alerted: Fire Brigade 122, Police 133, Ambulance 144. The alarm is normally raised by the organizer.

b) Dangers to be pointed out by the organizer:

(Imminent) dangers such as thunderstorms, fires, storms, etc. must be communicated to the visitors by the organizer immediately if they endanger the health of the visitors. A safety and evacuation concept for the event location will be drawn up by the organizer in advance and applied on site in the event of hazards.

In any case, keep calm and consider your own safety.

Authority to issue orders

Any orders and instructions (e.g. by announcements over the public address system or via megaphones) issued by the executive authorities, the organizer, the security service or the supervisors must be followed immediately and unconditionally by the persons participating. In the event of non-compliance, the person concerned may be expelled from the venue.
